RE-MYSELF AND EXPULSION FROM THE PATRIOTIC FRONT

I am in receipt of your letter dated 3 May 2019 **out of time** with a subject matter – EXPULSION FROM THE PARTY. I am of a known fixed abode and you should contact me for service of relevant communication without having to go through 3rd Parties as the case is

It is in public domain that I did make an appearance on Prime TV news and other media on which I on behalf of concerned fellow Patriotic Front youths and members have given an ultimatum for the Secretary General Mr Davis Mwila to vacate his position as Party Secretary General citing 8 reasons of matters of incompetence and misconduct on the part as required under article 13 of the Patriotic Front Constitution and I wish to respond and draw your attention to among other things below;

1. I am a member of high and good standing in the Patriotic Front and from its inception I have not belonged to any other Political Party apart from the Patriotic Front unlike you Mr Paul Moonga that has trekked between the UPND twice infact and the MMD
2. I am well vest with the Patriotic Front Constitution and guided by the same in all manner of action patronage and behavior
3. You are an interim executive with specific defined roles of administering the office of Lusaka Province only in an interim capacity with very limited mandate
4. In the subject matter of your missive, you cite my Expulsion before even giving me a hearing by a rightful assembled board of disciplinary panel
5. Your letter is not specific to any breach of the constitution and neither does it provide an approved disciplinary code of conduct for reference or minutes thereof
6. You have manufactured charges that are not provided for in the Patriotic Front Constitution a serious breach of PF rules

I have been directed to social media quotes in which you have demanded that I appear before a disciplinary committee on a date of 8th May 2019 and today 10th May 2019 without following simple rules of natural justice and the Patriotic Front Constitution and in summary please note among others what you have failed to do before going into further details of your letter;

1. You have not circulated a notice of appointment of a disciplinary panel
2. You have not circulated a notice for a disciplinary hearing with sufficient notice time

You may therefore note the above before considering the contents of your letter copy attached and any further missive over this matter and are encouraged to read the Patriotic Front constitution further before exposing your ineptitude and inadequacies in administration and bringing the name of the party into ridicule.

The Patriotic front Constitution is rich with rules and I am directing you to further read Article 13 part (e) that provides that a member has a right to;

To attend in person Party meetings that discuss and make decisions on his activities and Work, and to defend himself before appropriate Party organs on charges leveled against him and to appeal to a higher organ if he is not satisfied with a decision or judgment given;

This above is premised on the letter of expulsion served on me through 3rd Party and social media, a decision to expel me that process of the Patriotic Front Constitution is not followed.

You have a predetermined outcome as is evidenced from your letter and I would encourage you to recuse yourselves in this matter to allow you enough time to go and mobilize supporters for Mr Mwila and continue to endeavor to sing his praises which appears to be your principal preoccupation at the expense of mobilizing masses and support for President Edgar Chagwa Lungu

How can you in the same breath of a letter notify me of my Expulsion and also demand of my exculpation?

PETITION FOR MR DAVIS MWILA TO VACATE THE OFFICE OF THE S.G.

I now wish to draw your attention to the Petition for Mr Davis Mwila to vacate the Position of the Secretary General.

In representing concerned members in the call to have the Secretary General Mr Davis Mwila vacate the office of Secretary General, I have drawn my mandate from Article 2,7,14,15, in Chapter II of the Patriotic front Constitution.

Impliedly so as in article 2 part (b) it states “The Party demands hard work, honest, sacrifice and self-reliance in all activities to improve the living conditions and ensure greater benefits to the people of Zambia” which Mr Mwila is clearly falling short of.

Further, impliedly so Article 14 under the RIGHTS OF A MEMBER 1 (a)(b)(c) and (d) is provided that ;

Subject to the provisions of Patriotic Front Constitution, a member of the Party shall enjoy the following Rights:

- (a) **To eject** or be elected or appointed to the leadership in the organs of the Party;

- (b) To participate freely at Party meetings, in discussions on Party work and policies, and **to Present proposals on**, or to seek clarification to, any question on the life of the Party;
- (c) To attend in person Party meetings that discuss and make decisions on his activities and Work, and to defend himself before appropriate Party organs on charges leveled against him and to appeal to a higher organ if he is not satisfied with a decision or judgment given;
- (d) **To request the Party at all levels up to and including the General Conference to consider Any question or petition** provided the laid down procedures are followed;

Reproduced above for your ease of reference as you appear not schooled with the dictates of the Patriotic Front Constitution and its operations.

You will therefore note from the above that and be guided that I have at no time attempted to undermine the President of the Patriotic Front and I am in the forefront of informing the President of matters of Party and National importance to cement the President's fortress following the dictates of the Patriotic Front Constitution

In calling for the resignation of the Secretary Mr Davis Mwila, I am relying on my rights as a member in particular Article 14 1(a) that states that any member can **EJECT members in leadership organs of the Party** for which there is no specific platform provided in the constitution thereof

In all fairness and in earnest, the call for Mr Davis Mwila to vacate the office of the Secretary General is a summation and a follow-up to the pledge he made public himself that should we the Patriotic Front lose the Roan Constituency Bye Election, he would resign. This was done on public media and I see no wrong in a usual but firm followup.

Comrades Mr Kenndy Kamba and Mr Paul Moonga, be made aware that the position of Secretary General of the Party is provided for under Article 56 again reproduced for your ease of reference;

SECRETARY GENERAL OF THE PARTY

The Secretary-General shall hold office on full time basis and shall have the following powers, duties and functions;

- (a) Be the chief administrative officer of the Party responsible for the supervision, Coordination and efficient administration of the day to day activities of the Party;
- (b) To be responsible for Party organization and mobilization;

- (c) To be the Secretary to the Central Committee, National Council and General Conference;
- (d) To maintain a register of the Party's membership;
- (e) To be in constant Liaison with all the Section, Branch, Ward, Constituency, District and Provincial Committees;
- (f) To keep records, minutes and correspondence of meetings and decisions of the National, Provincial, District, Constituency, Ward, Branch and Section organs as well as of the affiliate organizations.
- (g) In the absence of the Secretary General the Deputy Secretary General shall deputize for Him.

From the above responsibilities highlighted and in his own public statement preceding the Roan Elections that he will resign in the event that the Patriotic Front lost the Roan Constituency Bye Election, you will note that the Secretary General of the Party Mr Davis Mwila plus other matters of misconduct has failed to fulfill his mandate of employment and has created conditions to be removed from the office and allow His Excellency the President to look to other members that can take us to the next level in appointments.

Comrades if guided with your human conscience and really take an introspection' deep down your hearts you are shouting loudly that 'Secretary General Mr Davis Mwila" is not steering the ship in the right direction as a matter of fact.

I have a petition to support the call for Mr Davis Mwila to vacate the Office of the Patriotic Front Secretary General for the attention of His Excellency President Edgar Chagwa Lungu President of the Republic of Zambia and the Patriotic Front which I intend to present by a Peaceful Procession on Thursday 16 May 2019 at 12:00 following notification to the Zambia Police in meeting obligations of the Public Order Act Chapter 113 for an on behalf of the General populace of Zambian Nationals that support President Edgar Chagwa Lungu and his candidature for 2021.

By copy of this letter, the Secretary General is reminded to interrogate his inner conscious as to whether his position remains tenable and if he has considered that it should be his intention to resign without necessarily having to be embarrassed with incompetence and misconduct charges in the Petition.

Further as a matter of principal, Mr Paul Moonga and Mr Kennedy Kamba, you should by now be aware that correspondence can not be copy of a letter to the President, communication to the President is "confidential at all times" and your actions are actually bordering on being insubordinate to the President and also grossly incompetent in your roles.

In conclusion, I wish to urge you to call upon your decent reasoning and curtail your excitement in protecting and singing praises for Mr Davis Mwila as the repercussions may be of grave Political consequences to you.

And to you my colleagues in the Interim Executive, it is sad reading that you fail to mobilize masses for the support of His Excellency President Edgar Chagwa Lungu and his defense and support but yet some of you have been complicit in very quickly to mobilizing masses never seen before in Kanyama to rally behind Mr Mwila who is subordinate to President Edgar Chagwa Lungu. I can only encourage you to be loyal to President Edgar Chagwa Lungu and not fall prey to the machinations of Mr Davis Mwila of drawing attention to himself at the expense of the leadership and party masses

Lets unite and stand countable in contestation to support President Edgar Chagwa Lungu and be prompt to point out to him matters weakening the party and stop fermenting cartels meant to curtail the endorsement of the Candidature of President Edgar Chagwa Lungu 2021
